

Limited Warranty

The warranty obligations of AEHTE LLC ("AEHTE") for this product are limited to the terms set forth below:

What is Covered

This limited warranty covers defects in materials and workmanship in this product.

What is Not Covered

This limited warranty does not cover any damage, deterioration or malfunction resulting from any alteration, modification, improper or unreasonable use or maintenance, misuse, abuse, accident, neglect, exposure to excess moisture, fire, improper packing and shipping (such claims must be presented to the carrier), lightning, power surges, or other acts of nature. This limited warranty does not cover any damage, deterioration or malfunction resulting from the installation or removal of this product from any installation, any unauthorized tampering with this product, any repairs attempted by anyone unauthorized by AEHTE to make such repairs, or any other cause which does not relate directly to a defect in materials and/or workmanship of this product. This limited warranty does not cover cartons, equipment enclosures including 3D printed plastic enclosures, cables or accessories used in conjunction with this product.

Without limiting any other exclusion herein, AEHTE does not warrant that the product covered hereby, including, without limitation, the technology and/or components and integrated circuit(s) included in the product, will not become obsolete or that such items are or will remain compatible with any other product or technology with which the product may be used.

How Long this Coverage Lasts

The standard limited warranty for AEHTE products is two (2) years from the date of original purchase, with the following exceptions:

- 1) All AEHTE **viaDNA Remote** hardware products are covered by a standard two (2) year warranty.
- 2) All AEHTE **Y-Adapter** hardware products are covered by a standard two (2) year warranty.
- 3) All AEHTE **viaUPS** hardware products are covered by a standard two (2) year warranty (excluding Lithium-Ion batteries that are covered for one (1) year).

Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.

What AEHTE Will Do

AEHTE will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

- 1) Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition. AEHTE will also pay the shipping costs necessary to return this product once the repair is complete.
- 2) Replace this product with a direct replacement or with a similar product deemed by AEHTE to perform substantially the same function as the original product.
- 3) Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.

What AEHTE Will Not Do Under This Limited Warranty

If this product is returned to AEHTE or the authorized dealer from which it was purchased or any other party authorized to repair AEHTE products, this product must be insured during shipment, with the insurance and shipping charges prepaid by you. If this product is returned uninsured, you assume all risks of loss or damage during shipment. AEHTE will not be responsible for any costs related to the removal or re-installation of this product from or into any installation. AEHTE will not be responsible for any costs related to any setting up of products, any adjustment of user controls or any programming required for a specific installation of this product.

How to Obtain a Remedy Under This Limited Warranty

To obtain a remedy under this limited warranty, you must contact either the authorized AEHTE reseller from whom you purchased this product or AEHTE. For a list of authorized AEHTE resellers and/or AEHTE authorized service providers, contact AEHTE.

In order to pursue any remedy under this limited warranty, you must possess an original, dated receipt as proof of purchase from an authorized AEHTE reseller. If this product is returned under this limited warranty, a Return Material Authorization number (RMA number), obtained from AEHTE, will be required. You may also be directed to an authorized reseller, or a person authorized by AEHTE to repair the product.

If it is decided that this product should be returned directly to AEHTE, this product should be properly packed, preferably in the original carton, for shipping. Cartons not bearing a return authorization number will be refused.

Limitation of Liability
